## Procedure:

- Combine phase A and stir with medium to high shear until homogeneous
- 2. Add B to A and stir with medium shear until homogeneous
- ⇒ SYNCRYSTAL Rose Opal gives the formulation a subtle, shimmering effect with a decent flop from pink to blue, while having a beige bulk color
- ⇒ TIXOGEL-IDD is a rheology modifier in form of an easy-to-use master gel, stabilizes the effect pigments. For a dry after feel it is the best choice due to its volatile components



Stable for at least 6 months at RT and 40°C. Stable for at least 1 month at 50°C.
